- 2. These are tenure vacancies under the funded project and are not employment on the JIPMER Pondicherry payroll. Employment will be automatically terminated upon completion of the project and there is no liability for permanent employment on JIPMER Pondicherry or Principal Investigator. Also, the candidates have no right to claim permanent employment based on this job. No benefit of Provident fund, Hostel accommodation, Leave Travel Concession, Medical Claim etc. will be considered, since the post is purely on contract basis.
- 3. Candidates who fail to bring the original certificates at the time of joining and if any discrepancy is found in the documents such candidates will not be allowed to join the selected contract post and the position will be offered to the waiting list candidates.
- 4. Age relaxation for SC/ST/OBC/PWD Candidates will be as per the government rules.
